January 22, 2019 meeting minutes were reviewed. Shelia made a motion to accept the minutes, Dennis was the second, motion passed.

Valarie provided an up-date on the job center performance measures for PY18 as of 4/11/2019. Goals are being met with the exception of Credential Attainment rate. There are several factors that are affecting this measure and staff are working hard to make the credential measure a success.

Committee members joined with the Youth Committee to discuss local benchmarks for the upcoming PY19 contracts. After much discussion and with some modification, the measures were voted on and approved. Shelia made the motion, Jim McFarland of the youth committee seconded, and the motion was passed by both committees. The One Stop benchmarks are:

**Approved program benchmarks for Adult and Dislocated Worker Programs**

1. 50% of all completed training will result in Training Related Employment each quarter.
2. 25% of all new training will be employer driven training (OJT, Apprenticeship, etc.)
3. 50% of all new WIOA participants will receive Financial Literacy services before exit.
4. 37% of Dislocated Worker funding will be spent on training for the total program year.
5. 32% of Adult funding will be spent on training for the total program year.
6. 20% of total budget will be spent each quarter.
