October 23, 2018 Meeting Minutes

Becky Brooks called the meeting to order at 9:55 am

Performance Measures for PY17: The program year July 1, 2017 to June 30, 2018 numbers were presented by Valarie Haring for the committee to review. All numbers were good except for the Adult Credential Attainment rate. This measure is still being affected by the NGCC Membership process when individuals entered their information into the system and it was not verified by staff. This resulted in numerous individuals selecting the first drop-down under education- "Attending Alternative Education"- even when they were not in school. These numbers should improve after the second quarter of PY18 when all of those individuals will no longer be in the measure.

Performance Measures for PY18/19: The board negotiated performance for the next two years with DWD. The numbers will stay the same or increase slightly in the next two years.

Adult Priority of Service Policy: A new policy was presented by Valarie for the committee to review. The region has received money from a Skill-up grant that concentrates on individuals receiving public assistance. The region was concerned about not being able to spend all the adult money with the current priority policy. The new policy will include a higher income level and added disability as a stand-alone priority for the adult program. Dennis Lancaster made a motion to accept the new priority policy and Shelia Barton seconded. Policy was approved by the committee and will be presented to the full board by Becky Brooks.

Shelia made a motion to adjourn the meeting, Dennis seconded, motion approved. Meeting adjourned at 10:51 am.
